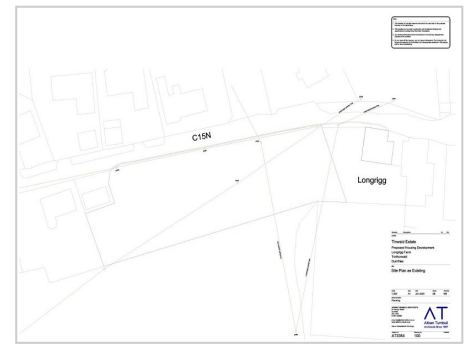
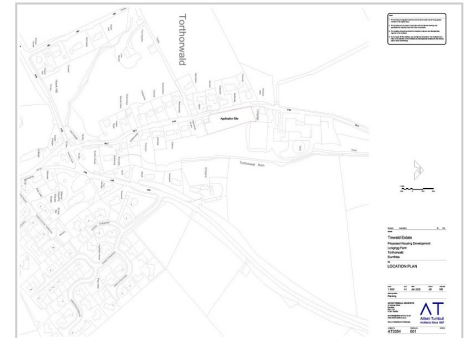

---

Planning Permission in Principle for the erection of four dwellings together with access, parking, landscaping, and associated works on land to the East of the C15n Shieldhill Road in the village of Torthorwald, Dumfries.

The site extends to approximately 2665 sq.m and is made up of an area of agricultural land which has been used for livestock grazing.

The site is available for sale as a whole (£300,000) or up to four individual plots (£75,000 per plot). Additional land to the East of the plots may be available for sale, subject to separate negotiation.

The site is at a similar level to the public road and is bound by an attractive stone dyke wall and rylock fence, with the East boundary currently undefined.

Planning permission in principle has been approved, subject to a number of considerations being met. The documents for this can be viewed on the Dumfries & Galloway website using the reference number 20/0605/PIP.

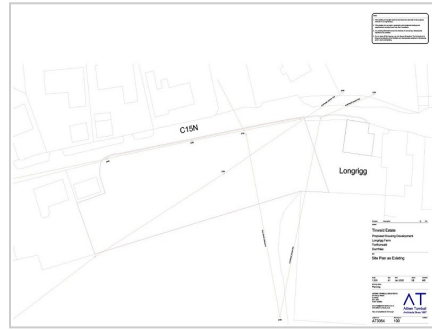
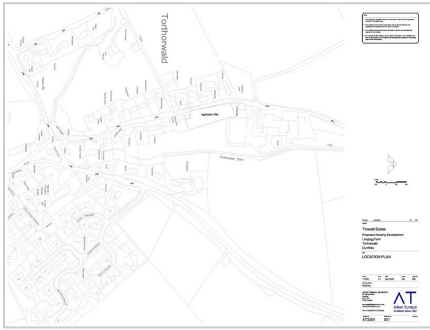
